Like almost all Internet sites, this one makes use of cookies. Cookies are small text files that the server of a Web site memorises in the user's browser (Explorer, Safari, Firefox, Chrome, etc.). When the user returns to the site, the server reads these cookies and therefore can customise and improve the user experience based on previous visits.

## **TYPES OF COOKIES**

There are different types of cookies, however, the main purpose of a cookie is fundamentally to make the site operate more effectively and to activate certain functionalities. Below are listed the types of cookies that can be used..

### **TECHNICAL COOKIES**

These are cookies that are essential to navigation within the site and the use of all its functions, such as the maintenance of the session, access to restricted areas and the user language. They are strictly necessary, as without these it would not be possible to provide the requested services. These cookies do not collect information for use for commercial purposes. As such, they are always used, regardless of user preferences.

Technical cookies also include those that are used to statistically analyse access or visits to the site that are designed solely for statistical purposes (but not marketing or profiling one) and collect information in an aggregate form without making it possible to identify the single user.

You can decide not to consent to the use of cookies on your computer by changing the set-up of the browser. You should, however, be aware that certain functionalities of the site may be disabled if you disable the cookies.

### **PROFILE COOKIES**

These cookies are used to collect information about the user to enable the communication of advertising messages in line with preferences exhibited by the same while navigating the Web (profile).

### **THIRD PARTY COOKIES**

Cookies of this type are used to integrate the functionalities of third parties in the site (e.g. forms for comments or social network icons that allow visitors to share the content of the site). Cookies of this category can be sent from the domains of site partners or those that offer the functionalities present in the site.

These cookies are also used to collect information on the use of the web site by visitors, the key words used to reach the site, the web sites visited and the origins of traffic from which the visitor



came for marketing campaigns. This site uses anonymized Google Analytics that collects the information in an anonymous form.

### **MEANS OF CONSENT**

The Owner is not required to request the consent of the user for technical cookies, as these are strictly required for the provision of the service.

The user must provide his/her consent for the other types of cookies (Art. 122 of Legislative Decree 196/2003). Consent can be given by the user, in conformity with the norm in force, via specific configurations of the browser or devices used. The user can modify or cookie preferences or cancel cookies at any time. Cookies can be deactivated from the browser at any time; however, this operation could prevent the user from using certain parts of the Site.
